Jacqueline Woodson on Africa, America and Slavery's Fierce Undertow

The African-American novelist journeys to Ghana, once a hub of the trans-Atlantic slave trade, as the nation invites descendants of enslaved Africans to call it their "home." But can you go home again?

IN THE COASTAL TOWN of Elmina, Ghana, the Atlantic Ocean crashes against the rocks with such ferocity, I make our kids move back away from the gray-blue water. Four hundred years have passed since captured Africans were forced across these waves on their way to bondage in the New World and now, standing at the edge of this violent water, startled by my own anxiety, I feel something deep and old and terrifying.



Now, Ghana has invited the descendants of the enslaved to a place it wants us to call "home." While Ghana is not the first sub-Saharan country from which Africans were forced onto ships, many black bodies, including my own ancestors, were sold and traded from here. In its efforts to bring the African Diaspora together, Ghana's leaders are also hoping to make amends for the complicity of Africans in selling their own people into what would become the trans-Atlantic slave trade.

Ghana's invitation is wrapped up in a massive marketing campaign called "Year of Return." The commemoration is described as a "landmark spiritual and birth-right journey," urging black folks to seek out our roots, invest in this country, and to educate our children on African soil. This year, there have been festivals, concerts, workshops and other events to mark 400 years since the arrival of the first captured Africans in the English colony of Virginia. But even as I stand at this shore, at once terrified and moved, I still feel some kind of way about this invitation. Curious. And cautious. "African-American dollars should be reinvested in Africa" reverberates through the Year of Return narrative. It makes sense that so many of us would much rather support blackowned businesses with our hard-earned money. But more than this, as I examine my unwillingness to tolerate America's insidious racism, its violence against black and brown bodies, and the daily micro aggressions so many people of color have long experienced, I find myself drawn to Ghana's offer.

But was Ghana drawn to me? And to my queer family? My white partner, Juliet, and our biracial children who, at 11 and 17, know half their DNA traces them to western Africa.

Ghana's Year of Return website celebrates "the cumulative resilience of all the victims of the trans-Atlantic slave trade." It promised everything from a welcoming World Music Festival to a Natural Hair Expo to a First Bath Of Return and Naming Ceremony in which participants, as is custom for African babies, are bathed, given African names and presented to their extended African family.

While these events sounded interesting and somewhat moving, it was not the way I wanted to see Ghana for the first time. I wanted the circumstance rather than the pomp. I wanted truth. I HAD NEVER BEEN TO AFRICA. But stepping out of that airport the first morning, it felt as though I had always known Ghana. The deep heat of the early morning so much like the South Carolina of my childhood. The dark bodies that seemed to fill every space easily absorbed my own dark body. And the smell — of petrol and cooking oil, of nuts roasting and plantains frying, of sweat and sewage — quickly swept me up out of jetlag into the right now of Ghana's capital, Accra.

We had planned to begin our journey here with a visit to the slave castles and forts on the coast. But like a curtain all of us were a bit afraid to open, we knew the trip would reveal more of what we already knew — that Africans, including children, were sometimes kept for months in dungeons, until enough were gathered to pack the hold of a slave ship. That some of the captured Africans died in confinement while others died during the Middle Passage, the longest leg of the triangular journey between Europe, Africa and the Americas.

And while I am completely sober in my knowledge that it was the evil of white folks that kept my ancestors in bondage for centuries, I found myself struggling to come to terms with those who worked with white traders to move black bodies into chattel slavery.

"The sad truth is that without complex business partnerships between African elites and European traders and commercial agents, the slave trade to the New World would have been impossible, at least on the scale it occurred," the Harvard scholar Henry Louis Gates Jr. wrote in 2010 in The New York Times.

We decided we needed a few days before facing the brutality of enslavement and headed instead to Shai Hills Resource Reserve, a wildlife and hiking retreat.



WE TRIED NOT TO IMAGINE what it was like. But, painful as it was, we imagined it anyway. Then, from the darkness of the haunting space, our guide stepped out into the bright cool air. With us still inside, he gently closed the gate. "This is the last place enslaved Africans ever saw in Ghana," he said. With the click of the latch, small sobs escaped from the strangers around me. "This is the point of no return," he said.

But we had returned. Different. Still alive.

Now, as the kids take selfies along the shore by the castle, the current has me again calling them away from the water. But the light, Mommy, my daughter calls back, reminding me, that at 17, in the age of Instagram, even this far from our home in Brooklyn, it is still a moment's light that matters most.

AS TRUE AS AN UNDERTOW, I feel the water pulling me back across it, taking me to where it took my ancestors centuries ago. To a land as foreign to them as the African chiefs who offered brown bodies over for weapons, brass and cotton. As foreign as the white captors who raped, brutalized and enslaved those same bodies. I feel the pull of the history that brought me here. And the history that took me away. A feeling as old as my body itself overcomes me — that I have never felt whole in one place. In Africa, like America, I am only halfway home. My body belonging to both and neither place.

When plastic surgery goes wrong...

ody enhancement is a growing business in the world today, even though the procedure is expensive, both ladies and guys, especially women, will give all it takes to have that perfect body.

While some celebrities leave you to your imagination and do not reveal that they have gone under the knife, some show off the new banging body.

Well...incase you are planning to have that 'perfect' hour glass body, the curviest bum, or you are planning to remove that extra fat in your stomach area before the new year, relax and read up!

Yosha Fowler awoke to a nightmare. A month after an outpatient plastic surgery procedure, the Detroit native's eyes fluttered open. She heard machines beeping, and her mother crying out her name. Fowler's abdomen gaped open. And she couldn't walk.

Fowler learned that Dr. Osakatukei Omulepu had accidentally punctured her bowels during liposuction and injected fat into her sciatic nerve during a Brazilian butt lift at Spectrum Aesthetics in Florida, according to interviews and Department of Health records. Hospital personnel trying to repair the damage had placed the 35-year-old in a medically induced coma.



Four blood transfusions and seven surgeries later, Fowler was just beginning her recovery when she regained consciousness. By then, her medical treatment costs had already soared over a million dollars.

After insurance paid a share, Fowler still owed the hospital hundreds of thousands of dollars. She lost her job and was evicted from her apartment. Bills piled up. Fowler's mother connected her to an attorney to sue the doctor.

That attorney, Michael Grife, called Fowler's case heartbreaking – one of the most horrible he'd seen. But there was a

hitch: Omvlepu was practicing without medical malpractice insurance. Grife withdrew from representing Fowler; there was little chance she could recoup money for what the doctor had done. She never sued.

Omulepu told USA TODAY he doesn't remember why he opted out of medical malpractice insurance, although he noted it is expensive.

"Why pay it if you don't have to?" he asked



Nearly 6,900 doctors in Florida lack malpractice insurance or other coverage, colloquially referred to as "going bare," a USA TO-DAY investigation has found. When they maim and kill, there's less recourse, leaving patients damaged physically and financially, with families struggling to pay medical bills.

Those physicians have been disciplined 44% more frequently over the past decade, and they are more likely to have committed criminal offenses – mostly for driving under the influence, according to USA TODAY's analysis. In all, 110 of those physicians without insurance are licensed to practice in Florida after facing disciplinary action in other states.

While only a handful of states require doctors to carry malpractice insurance, lack of coverage creates a serious mismatch with Florida's status as a national destination for discount plastic surgery procedures, including the Brazilian butt lift.

In Florida, 1 in 5 board-certified plastic surgeons are elected not to carry medical malpractice insurance, based on USA TODAY's analysis of insurance information reported by doctors to the Department of Health. That figure does not include doctors who per-form plastic surgery without certification, which Florida allows. Omulepu, for one, was not certified.

This can enable doctors with repeated medical malpractice cases to stay in business without having to pay higher insurance premiums. Despite the high level of risk involved in some plastic surgery procedures, including the fat transfer process of a Brazilian butt lift, Florida's oversight system has few built-in checks and balances.

The state only enacted stricter regulations after a USA TODAY and Naples Daily News investigation earlier this year revealed dangerous practices in two clinics overseen by the same doctor. Eight of the clinics' patients died after surgeries, nearly a dozen more needed to be hospitalized.

It was the fifth time since 2014 that such legislation had been proposed.

In Florida, doctors self-report whether they carry medical malpractice insurance. The Florida Department of Health does not verify whether they are telling the truth. Nor does it confirm that doctors without insurance have other funds available to pay claims that arise.

In three of the cases examined by USA TODAY, doctors told the Department of Health that they carried malpractice insurance. When a patient's attorney asked later, those doctors said they did not have it.

Even when patients can find an attorney willing to take their case and manage to get court judgments for their injuries and financial setbacks, they may not be able to collect. The Florida Financial Responsibility statute requires physicians to pay judgments up to \$250,000, but federal bankruptcy law creates a loophole in which physicians can file for bankruptcy instead. According to a 2010 article in the University of Miami Law Review, the state medical board can't discipline them for doing so.

In the end, Grife said, it is the patients who lose. He described it as an epidemic that affects thousands, if not tens of thousands of patients each year. "In Florida, unfortunately, there are many plastic surgeons who do a lot of harm to patients – who either kill them or leave them on death's door," Grife said, "and then they do not have the means to compensate the patients that they've harmed."



his eight about 20 Named 1

his eight-acre private island is in Rangiroa, a coral atoll in the Tuamotu Archipelago of French Polynesia, about 200 miles northeast of Tahiti in the South Pacific Ocean.

Named Motu Teta, the island includes a three-bedroom, two-bathroom villa, as well as two additional residences. The villa was built in 1984, with exposed wood-beam ceilings, a broad terrace and wooden pull-down

shutters. White-sand beaches and crystalline waters teeming with tropical fish encircle the islands of Rangiroa, making it a scuba -diving destination for tourists.

"There's a nice wind all the time there," said Jacques C. Menahem, the owner of French Polynesia Sotheby's International Realty, which has the listing. The property has been rented as a vacation home for more than \$3,000 a night.

The island is self-reliant, said Mr. Menahem, who compared living there to living on a boat. To that end, the island's equipment includes a rainwater cistern, two generators (one for backup), solar panels, a tractor and several boats. There is no internet access, and cellular coverage is spotty. (Mr. Menahem said that internet access is expected within the year.)



A broad wood terrace serves as the main entrance to the 2,250-square-foot villa. A one-bedroom suite with a king-size bed is at either end, with a spacious living area, dining room and kitchen in between. A third, smaller bedroom is behind the kitchen. The ceilings have wide beams, and the floors are made of local hardwood, Mr. Menahem said. The terrace overlooks the turquoise

lagoon, and the beach is a few yards away.

A 765-square-foot bungalow about 50 yards from the main house has a terrace with a kitchenette and wet bar. Inside are a bedroom and a bathroom adorned with tiny coconut trees planted behind the double sink and vanity. A separate building for staff has three bedrooms and a small kitchen. Rangiroa, which has about 2,500 residents, is the largest of the Tuamotu Atolls. Motu Teta, one of more than 400 land masses that make up the atoll, is surrounded by waters filled with fish, but for other food and supplies, a boat is needed to get to the main Rangiroa towns of Tiputa and Avatoru, Mr. Menahem said, about 75 minutes away. Essentials like a pharmacy, a bank and medical facilities are also there.

"It's expensive to maintain an island," Mr. Menahem said, but the expense and lack of convenience are more than made up for by the serenity. Motu Teta, which has no light pollution and cooling breezes, is the most beautiful island he has ever visited, he said, and "I've seen a lot of islands."

#### Market Overview

The housing market in French Polynesia, a French collectivity with 280,000 people spread over more than 100 islands in the Pacific Ocean, is undergoing "a transformation," said Emily Biotteau-Colas, the owner and managing director of Tahiti Homes, an agency in Papeete, the capital city.

Location "is more important in French Polynesia, because the quality of real estate is very poor here," she said. "It's very recent that people are paying attention to the décor or architecture."



But in the past decade, the home décor industry there has "exploded," she said, which has inspired people to build larger homes.

French Polynesia has seen recent increases in prices and sales, buoyed by economic stability and a housing shortage, Mr. Menahem said. On the popular tourist island of Moorea, he estimated, prices have risen as much as 25 percent in the past year.

"It's going so good that I found myself with a new problem — that I don't have stock," he said. "What I've had I've sold, and it's difficult to find new properties for sale."

That is in stark contrast to the market of several years ago, when prices stagnated and homes remained unsold.

Francois Perinetto, the director of Groupe Thisse, an agency in Tahiti, said prices there have not increased, but sales have, sharply. "We used to sell 10 to 20 houses per year," he said. "Now we sell more than 50."

Several factors have contributed to that, the agents said. One was the 2014 election of President Edouard Fritch, who took office after the resignation of Gaston Flosse amid a corruption scandal. These days, Ms. Biotteau-Colas said, "locals are confident in the agovernment."

New resorts and expanded air service between Tahiti and the United States since 2018 have brought an influx of tourists, which has lifted the local economy and increased employment, Mr. Perinetto said. That, in turn, has allowed French Polynesians to invest more in real estate. Lower interest rates have also made buying property more attractive.

And as a result of the tourist boom, some rental homes have been converted to Airbnb properties, further reducing supply, agents said.



Moorea is about 20 minutes from Tahiti by boat, making it a popular second-home destination for Tahitians and foreigners. "It still offers an authentic Polynesian lifestyle, as well as great sceneries and beautiful white-sand beaches," Ms. Biotteau-Colas said. A two-bedroom villa in a gated community on Moorea, she said, sells for around \$370,000, while a private island in Bora-Bora could fetch up to \$40 million. Upscale, single-family, three- or four-bedroom houses in nice areas of Puna'auia range from about \$1.4 million to \$2 million. Similar homes in desirable hillside neighborhoods start at about \$800,000.

Mr. Perinetto said luxury homes start at \$1 million for a three- or four-bedroom in a desirable neighborhood on Moorea or Tahiti, with a pool, a sunset view and security. He estimated that there are 20 to 50 luxury houses for sale across French Polynesia. "The market is so small," he said, that "when people want to buy, they buy an atoll or a private island and they build directly."

#### Who Buys in French Polynesia

While the vast majority of Mr. Menahem's clients are local, he said — "90 or 95 percent of my buyers are people from here" — in the past couple of years he has seen an increase in American, Italian, Spanish and French buyers.

Ms. Biotteau-Colas said that her agency has recently had clients from the United States, Switzerland and France. But many foreign buyers may not find what they are looking for in French Polynesia,



she added: "We do not have mansions or estates like they can find in the French Riviera, California or Florida."

Mr. Perinetto said that most of his clients are Polynesian; only 10 to 20 percent are foreigners, and they are vsvally French.

#### **Buying Basics**

There are restrictions on foreigners buying property in French Polynesia, said Jeanne Lollichon, an owner of a notary firm in Puna'avia. "We don't have so much space, and people here are very attached to the land," she said. Potential buyers must obtain governmental permission, which is granted on a case-by-case basis. Citizens of the European Union are exempt, she said.

French law applies in French Polynesia, and as in France, property transactions are handled by notaries. Closing



costs, which are the same for local and foreign buyers, include the notary fee, registration tax and other smaller charges; they typically total around 12 percent of the sale price, she said.

Transactions are done in CFP francs, which are pegged to the euro. If a property is listed in another currency, like the euro, it is for marketing purposes. The notarized deed is in local currency, she said.

# US retailers hit by 'worst year since 2008' for discounting

#### Steep promotions last long beyond Black Friday to woo customers

US department stores and clothing retailers, trying to weather the continued onslaught of online shopping, are resorting to some of the biggest discounts since the 2008 crisis to woo consumers, heightening concerns of a squeeze in profit margins.

With less than two weeks before Christmas, industry data show special offers have lasted long beyond the traditional Black Friday promotional period and are also steeper than in previous years.



"This is the worst year for discounting since 2008," said Jan Rogers Kniffen, a retail consultant, of clothing and mall-based retailers. He noted that the discounts came in spite of robust US consumer spending. "Outside of a recession, it's the deepest I've seen.

" Within the past week, executives at some retailers have put investors on notice over the scale of discounting. Bob Madore, chief financial officer of American Eagle, told analysts that "an increase in promotional activity" was set to put pressure on the clothing retailer's profit margins. "The beginning of the holiday season has been softer than expected," he said.

Dinesh Lathi, chief executive of Houston-based men's formalwear company Tailored Brands, described the environment as "heavily promotional". The deep sales among the retailers hardest hit by the rise of online shopping come even though other retailers, including Walmart and Target, have sent reassuring signals over the financial health of the US consumer.

MasterCard forecasts that US retail sales will rise 3.1 per cent between the start of November and Christmas Eve from the same period a year ago, led by ecommerce.

At mid-market department stores, about two-thirds of merchandise was still on sale last week, according to data companies StyleSage and Refinitiv. Average discounts, at 27 per cent, were only slightly less deep than during the Black Friday weekend.

Jharonne Martis, director of consumer research at Refinitiv, said: "If companies continue down this path, it will put them at a higher risk of default."

Government data published on Friday showed the figures for November were weaker than expected, although they still rose 3.1 per cent year-over-year.

However, sales at department stores dropped 7.2 per cent from a year earlier, clothing store sales 3.3 per cent and electronics \$
appliance stores 1.5 per cent.

Retail executives have highlighted particular pressure on shopping centres. Jane Elfers, chief executive of Children's Place, a New Jersey-based clothing retailer with about 970 stores, said last week that footfall in malls was "meaningfully weaker" than expected. Trade tariffs were a complicating factor, Ms Martis added. Although Washington and Beijing reached a partial trade war truce on Friday, retailers had already accelerated shipments through ports to avoid being subjected to the threatened tariffs. This had left some companies with extra inventory that they now needed to shed.

Retailers welcomed the trade agreement where the US will not go ahead with levies on \$156bn worth of consumer goods from China that were due to be introduced on Sunday.

that the tradition started as a crude way of storing fresh fish before the era of refrigerators.





*Choose one made of a crease-resistant fabric:* "Modern technology enables cloth merchants either to comb the yarns during manufacture or to add a twist to the yarn. Both give suits a natural spring, helping them to return to their original shape after creasing. A good example is Crispaire fabric from Holland and Sherry".



*There is one clever way to fold your jacket without creasing it:* "Turn one shoulder inside out, and slot it inside the opposing shoulder. The collar and lapel will create a nice fold. Finally, fold the whole suit in two. Wait until everyone has placed their bags in the overhead lockers and then slide your jacket on top".

*Invest in a decent suit bag:* "Gate 8 sells a cabin bag for suits called the Tri-fold Garment Mate. You can also use this as your carry-on bag since it has a laptop bag attached. Otherwise, you could carry your suit in a normal garment cover and, during security checks, roll it up and pack it into your carry-on bag. But take it out and hang it once you're on the plane".

*Ask cabin crew if they can hang your suit for you on board:* "Even in economy class, most aircraft have wardrobes that they reserve for bridal dresses. If it's not full of wedding dresses, quite often crew will hang your suit if you ask nicely".

*There's an easy way to combat creases:* "Turn the shower on as hot as possible. Close the door, fill the room with steam, and leave jacket and trousers on separate hangers in the bathroom for ten minutes. That will get rid of any creases".

#### Loblaws

Start outside Canada's largest supermarket chain, Loblaws, on Portland street and Queen Street west. Here, the developer has respected the local area by having shops at street level, echoing the smaller-scale retail on Queen Street West—the supermarket is on the upper floor and Winners fashion store on the next level up. Inside, despite being new-build, there's a slight industrial warehouse feel that fits with the general area. Before you turn west, look at the painting of a giant eye on a building further east on the south side of the street. The mural is by US artist Shepard Fairey, best known for his Hope poster of Barack Obama created during the 2008 US elections. The building used to house a popular night club called Tattoo.

#### Theatre Passe Muraille

Queen Street West was the baseline established by the Royal Engineers when they laid out the town of York (now Toronto) in 1783. Formerly Lot Street, it was renamed in the 1840s in honour of Queen Victoria. Despite being a heritage conservation area, it is an important east-west corridor with streetcars running along it. Cross the road and head north on Ryerson Avenue, past the new Workplace One, an example of the district's former factories and warehouses which are now loft apartments or workspaces. Check out Theatre Passe Muraille, located in the former Nasmith Bakery and Stables. One of the city's top independent theatres, in January it is showing Suitcase/Adrenaline, a production about the experiences of Syrian refugees.

#### Black Squirrels

Ryerson Avenue is a street of humbly constructed houses that shows the effect of original city planning, which stopped buildings away from the main streets from being higher than three storeys. It also has conservation park areas, where, season permitting (in winter they tend to hibernate), you might see distinctive black squirrels running along telephone wires and electricity cables. These are in fact called the Eastern Grey, but those with black fur dominate. Various explanations have been put forward for their colour, from the presence of black asphalt in roofs, meaning they are more camouflaged from hawks, to the fact that black fur provides mire insulation in harsh winters. The mutants gene may also be down to greater levels of testosterone — the black squirrels are more successful at breeding than their brothers. You have to be aggressive to survive in the city.

#### Market 707

Head up through Alexandra Park, which was created from the gardens of a now demolished house and expanded in the 1960s as the city knocked down old properties and built new ones in the hope of regenerating what was a working class area. The communities themselves have formed local groups and engendered the sense of neighbourhood spirit that is tangible here. You'll see gardens in schools where pupils grow vegetables and herbs, while at Market 707 you can try a range of street food. Founded in 2010 by the Scadding Court Community Centre, who got the idea from a trip to Ghana to turn old shipping containers into vending stalls, it serves up international food (Japanese, Afghan, Thai, West Indian) as well as local specialities. It's located on Dundas Street, which was named after Henry Dundas, the first Viscount Melville, who never even visited Toronto.

#### Kensington Market

Head north along Denison Avenue and you'll enter the Kensington Market area, home to shops and apartments, through Bellevue Square Park—named after a mansion once here that was owned by the influential Denison family. Characterised by Victorian-era houses, this area has been multicultural for well over a century, settled by the English then, in turn Russian and Polish Jewish communities, and waves of new immigrants from Italy, the Caribbean, Latin America and Asia. Currently the distinct faces a challenge from Airbnb, hence the signs about the area being "more than a one night stand". It's a great place for sampling a range of cuisines inexpensively, (try Rasta Pasta for Jamaican–Italian fusion or Nu Bugel for Montréal–style bagels with smoked trout) and buying everything from tourist mementos to local cheese. You can also legally buy marijuana in the city from registered outlets, and smoke it in lounges such as Hotbox Café (which missed out on a licence to sell it as these were awarded by lottery).
